Smoking Policy

1. Introduction

1.1. The following smoking policy is legally enforceable and actionable within the Central Film School demise and all of its network of schools. Its aims are to allow all students the right to a healthy and smoke free environment. This policy also notes that it is the responsibility of smokers to ensure the health and welfare of all students.

2. Legal requirements

- 2.1. This Smoking Policy describes Central Film Schools (CFS) approach to undertaking its duties under the Health Act 2006 and The Smoke-free (Premises and Enforcement) Regulations 2006.
- 2.2. All university premises are designated as no smoking areas, as described in the 2006 Regulations. Smoking is not permitted in any enclosed areas either internally or externally within our demise.
- 2.3. Use of e-cigarettes/vaping is restricted in the same way as tobacco.
- 2.4. Smoking and vaping are also not permitted near the entrances to the school building. The aim of this is to allow colleagues and contractors, students and visitors to access and egress the buildings without being subjected to significant smoke or vape fumes and to prevent the ongoing problems of smoke or fume ingress into offices and teaching spaces when windows are opened.
- 2.5. The disposal of refuse from smoking/vaping is the responsibility of the smoker/vaper. Smokers/vapers should be aware that enforcement action has been taken against individuals by the local authority for inappropriate disposal of smoking/vaping waste. The Operations

department is responsible for the display of no smoking/vaping signage on university premises.

3. Enforcement

- 3.1. All colleagues and students, contractors and visitors will be responsible for complying with this Policy. It is expected that all colleagues will take responsibility for dealing with any breaches they observe. The practical steps for dealing with breaches are as follows:
 - The initial response to anyone noted to be smoking/vaping immediately outside/ inside Avondale Hall will be to indicate the no-smoking/vaping signs; to ask the person to stop smoking/vaping or ask them to move to an outside area.
 - A further response is to tell the person smoking/vaping that an offence would be committed if they were allowed to smoke/vape; and they are breaking the law by smoking/vaping on premises or in a university vehicle.
 - If they refuse to stop smoking/vaping, the Senior Operations Manager/Head of School/CEO will be contacted.
 - Breaches will be reported using the incident reporting process.
 - Persistent offenders will be subject to the published school's disciplinary procedures or, in the case of a visitor/contractor, asked to leave the premises.
